Job Description Swimming Teacher

Purpose of Job: To deliver lessons which motivate, educate and encourage children of varying abilities

Qualifications required : Current ASA/STA Level 2

Reporting to: The Head Teacher and PE Lead

Key Responsibilities

- To plan and deliver swimming lessons at Knights Templar Community Church School, ensuring adherence to the lesson plans.
- To be a positive role model, creating a positive and fun environment in which to motivate and encourage children to participate in swimming, welcoming all participants in a professional and friendly manner.
- Ensure safe provision of all equipment and ensure it is used correctly, operate within Health & Safety guidelines and undertake risk assessments.
- To carry out Fire Evacuation Training with the children.
- To follow the school's behaviour policy and ensure that high standards of behaviours are maintained in all sessions.
- Identify participants' abilities and encourage them to reach their full potential, planning and delivering sessions appropriate to the level of swimmer.
- For the duration of the lesson, to instruct, provide explanations and demonstrate swimming techniques, correct faults in swimming techniques and identify ways to improve performance.
- To log and report any incidents/accidents or any other concerns to the Head Teacher or Senior Teacher.
- Attend regular training and updates including Fire and Evacuation Training.

- To constantly update, manage and complete your registers, which must remain on site.
- Teach with full regard to H&S coordinating and communicating with other teaching assistants on the pupils in a class and supervision required.
- Work closely with the PE leader.
- Report any safety concerns or health and safety issues to the PE leader and the Head Teacher.
- Produce yearly progress reports for each child.
- Organise the groupings for swimming lessons to ensure children are challenged and supported.
- Prepare certificates for children as they progress through the swimming grades.
- Teach the children water safety.

General Duties

- To arrive in good time before the lesson start time, to ensure facilities are set up appropriately and to leave the pool in a clean and tidy state at the end of each session.
- Present and conduct yourself in an appropriate manner with courtesy and regard for others.
- Wear suitable clothing for teaching when in and out of the water and when leaving or arriving on site.
- Maintain your qualifications, ensuring they are up to date and relevant.
- Attend team meeting training session /employee review sessions/ CPD courses as recommended.
- To follow all school policies and procedures.
